Legislative Report

The 2004 legislative session is expected to complete its work on June 17, so-called "veto" day. On that day the General Court takes up all bills the Governor vetoed this year. Since a 2/3 vote to override a veto is required, it is unusual for a bill to go into law over a governor's veto particularly this year when both bodies and the Governor are of the same party. The governor vetoed six bills: SB 513 which would raise the death penalty to age 18; SB 470 raising the fee for renewal of physicians licenses; SB 484 allowing pharmacists to dispense emergency contraceptives; HB 503 requiring municipalities to assure access to septage facilities or else stop new development; HB 520 which requires keeping records on greyhounds used in racing; and HB 1134 that sets a five year term for Chief Justice of the NH Supreme Court, a law the NH Supreme Court has declared unconstitutional. Probably there will be many debates on some of these but it is not likely to result in any overrides.

As reported earlier, SB 302 allocating \$428 million in state grants for public education passed the Senate. In the House it was amended to the satisfaction of a large bi-partisan (veto-proof) majority. However an additional \$28 million expense was added, to be paid by a 17 cent addition to the cigarette tax. This occurred in spite of knowing the Governor was opposed to that additional tax and would probably veto the bill. That House amendment put the bill into Committee of Conference because the Senate version differed with the House version. Then a so-called private letter from the Attorney General to the Governor, the Senate President, and the House Speaker was leaked to the Nashua Telegraph revealing doubts by the A.G. that the bill in either form was constitutional! Who leaked the letter? That development led to a revised form of the bill prepared in a hurry by members of Conference Committee. Surprisingly (to me) that amendment passed much to the consternation of many in the North Country, in Manchester, and in so-called donor towns, whose cities and towns receive less state grant support than in the prior form of the bill. The donor-towns return whereas in the prior form of the bill they were substantially eliminated. Now a coalition of forces is forming, led by Manchester and Portsmouth, to see whether they have cause to sue the state to force the legislature to adopt another form of the law. The Governor urged us to pass this version of the bill but in spite of so urging he simply let it go into law without his signature! Stay tuned!

SB 376 is another key financial bill since it substantially revises how we handle Medicaid expenses and payments to hospitals and nursing homes, as negotiated by the Governor with the Federal government. The Governor opposes a requirement in the bill that he obtain legislative approval for any further arrangements his Health and Human Services agency may make under the bill. Therefore the Governor is likely to either let the bill go into law without his signature (he has five days to decide after receiving a bill) or to veto it. If vetoed it may well be over ridden in votes of the General Court as there is no interest in either party to give up major authority over financial matters to any Governor.

The House in HB 1292 and the Senate in HB 264 amended re-districting as laid out by the Supreme Court last year. Once again Democrats sued against these laws primarily because they argue the NH Constitution only allows one re-districting every ten years. I don't read it that way and am supporting a petition for the Court to deny the minority party petition. Registration of applicants for nine Senate districts are held up by the Court as are all but 35 House districts. All evidence on the issue was submitted by June 8 and a court hearing will be held on June 10. Presumably there will be a decision by the court shortly thereafter. I have already declared my intention to run for a fifth term.

In spite of dire warnings about a \$300 million deficit in the next biennium the State, as of May 2004, has received \$1,953.3 million which is \$24.4 million ahead of plan and \$88.3 million ahead of last year. However, loss of one-time money, Federal money, and the so-called legacy tax will put a severe crimp into the next biennium budget that only a strong economic upturn can at least partially alleviate. The next Governor's budget proposal in February 2005 will be a "work of art" since both parties' major candidates have taken the pledge to veto income or general sales taxes!

As reported earlier, HB 1160 to expand the membership of the board of professional geologists to include the state geologist as an "ex officio" member was the only professional board law passed as a landscape architects bill did not appear. A number of bills were filed dealing with various professions including certified public accountants, dieticians, medicine, and physicians assistants but none for professional engineers directly, thank goodness. Have a great summer!
